

The Rechargeable Li-ion Battery (B21G) had passed the UN 38.3 test and is classified as non-dangerous goods and also complies with the UN Recommendations on the Transport of Dangerous Goods; IATA Dangerous Goods regulations, and applicable U.S. DOT regulations for the safe transport of Rechargeable Li-ion Battery.

Each package must be labeled with a Lithium Battery handling label.
